1. 根據香港法例第 615 章《打擊洗錢及恐怖分子資金籌集條例》(下稱「《打擊洗錢條例》」) 第 53S, 53T 及 53U 條的規定，除非公司註冊處處長(下稱「處長」)給予書面批准，否則任何人不得成為信託或公司服務持牌人(下稱「持牌人」)的最終擁有人／合夥人／董事。持牌人須使用本表格向處長提出申請有關批准。
2. 在作出申請前，持牌人須閱讀處長發出的《信託或公司服務提供者發牌指引》，了解向處長提出申請批准某人成為持牌人的最終擁有人／合夥人／董事的規定及程序，以及就有關規定的豁免。上述指引可於公司註冊處(下稱「本處」)信託及公司服務提供者發牌制度的網站(www.tcsp.cr.gov.hk)下載。請注意，上述第 1 段的規定並不適用於《打擊洗錢條例》第 53B 條所述各類別的人士，包括：-

Under sections 53S, 53T and 53U of the Anti-Money Laundering and Counter-Terrorist Financing Ordinance (Cap. 615) (“the AMLO”), a person must not become an ultimate owner / a partner / a director of a trust or company service provider licensee (“licensee”) unless the Registrar of Companies (“the Registrar”) gives approval in writing.  - (f) to provide a certified copy of an entry in / an extract from the Register or a certificate issued by the Registrar under the AMLO to any person subject to payment of a fee; and
 - (g) to disclose to the public the material facts of cases in which the Registrar exercised disciplinary powers under the AMLO.
2. Provision of the required personal data to the Registrar is obligatory for compliance with the AMLO. The Companies Registry will not be able to process the relevant applications / notifications if the required personal data are not provided.
